## Covid-19 End Game

**First to level set and alleviate fear. The odds of testing positive for Covid-19 in Canada in the next year is 1 in 30, assuming vaccines have ZERO effect. And of those who test positive just 2.4% will need hospitalization. Obvious, odds vary by population density (spreads easier). In my region the odds of a positive test are 1 in 142. **If** vaccines work, the odds could be a lot more in our favour.**

I have spent about 400 or 500 hours looking at Covid-19 data, scientific studies and interviews of experts in the field over the past 16 months. That may seem like a lot of hours but really it is just 1 or 2 hours per day where I generally spend 7 to 10 hours 4 or 5 days a week looking at stocks, economic and market data etc. **I will not be spending much more time on Covid-19, really there is not much more I can learn.** The only thing left is the end result, we are in the 8<sup>th</sup> or 9<sup>th</sup> inning of the **current** pandemic. I am no longer going to provide many links to data as in the past, you can go to playstocks.net to see the past data.

## Covid-19 conclusions

I have followed most closely in Canada, US and UK. In general Covid-19 numbers were greatly exaggerated and lied about in order to create fear. [The scientific advisory board to Covid-19 in England](#) admitted so and claimed the fear was created so the people would adhere to Covid-19 regulations and lock downs etc. I think it is easy to see this fear card was played by most governments and their main stream media. **It still is today, by hyping fear about variants when the science proves they are of little significance.** A variant generally changes less than 1% from the original strain. There have been thousands of variants of influenza [with about 60 now dominant today.](#)

Sweden did not implement any Covid-19 restrictions and their end result is not any different and in fact their death rate is lower than other countries I follow. Sweden Covid-19 death rate is 1.3%, lower than Australia at 2.9%, UK at 2.6%, US 1.8% and Canada at 1.8%, As is the case in all countries, the vast majority of deaths are the elderly and frail. If you are 70 or younger and in good health, the death rate is about 0.02%. Keep in mind that deaths were likely exaggerated leading to the higher rates than Sweden reported.

The data, even that provided by governments prove that Covid-19 is not really much deadlier than a bad flu season and same with hospitalization. **Why the lies and exaggeration? I will get to the most popular theories**, but a couple notes on this Covid-19 no big deal topic. On Monday July 5<sup>th</sup>, I was shocked when I heard news on TV report truthful data about Covid-19 numbers in my district. They reported just 5 or 6 news cases and 198 people in hospital and 1 new death. Very typical and this is just death number 4 in my district since Covid-19 began (+1 from outside my district), so a very low number, like a bad flu season as pointed out above. **However what surprised me is when they reported 198 people in hospital, they clarified and went on to say only 2 of those in hospital were Covid-19.** This is the first time I heard this reported properly by main stream media in Canada, usually they just leave it at number of people in hospital so it sounds like they are all Covid-19 hospitalizations. I have tried to explain this to people and most remain convinced all the hospitalization is Covid-19. **Either simple ignorance or brain washing?**

A few weeks ago England Health reported Covid-19 data for either the 1<sup>st</sup> or 2<sup>nd</sup> week of June and they reported **74 Covid-19 related deaths**. However they went on to say that in that week just **1 in 130 of the deaths were Covid-19** and that **influenza and pneumonia killed 3 times more people as Covid-19**. As I pointed out the narrative has changed in the UK and US but not Canada thus far. I am hoping the accurate main stream news report in my area might be the beginning of a change in narrative in Canada that better reflects the truth. Could this be the first sign of a trend to alleviate fear in Canada? Probably not.

I have been following news out of the UK for over 10 years because I find they more often report more accurately on events in North America (not so biased). I noted months ago that the UK seemed to be changing their narrative on Covid-19. [The UK has now removed all restrictions](#) (“the country must learn to live with Covid”), masks and social distancing are now voluntary, everything is open and there are no vaccine passports, that idea was squashed and it should be. Never the less, the fear mongers are still out there. [Sajid Javid, Health Secretary warns](#) cases could top 100k a day by August. And Professor Lockdown fears 200k cases per day. **What nonsense!!!!**

Covid-19 is very seasonal like the regular flu. That is why numbers in Canada are coming down and won't rise much in the UK, not because of the government lock downs and restrictions. I am watching Australia because their flu season is opposite ours and now just starting. Sure enough the Covid-19 cases are starting to rise and are now at their highest level since September 2020. In 2020 Australia seasonal peak was in early August.

These experimental vaccines have only been out about 5 or 6 months depending where you live, but Israel was the first to do an aggressive vaccination campaign using Pfizer. **Israel is more like the 1<sup>st</sup> real trial, not just after 14 days that Pfizer reported on their trial data to the FDA. Israel, by the numbers: Pfizer's vaccine protected 64% of people against COVID-19 between June 6 and early July, down from a previous 94%.** This is still early days in this experiment. The influenza vaccine is typically 30% to 50% effective any given year. These new vaccines many not be any better they could even fare worse, only time will tell.

### **Reports of deaths and serious injuries from the COVID-19 jabs mount by the day.**

- As of June 11, 2021, the U.S. Vaccine Adverse Events Reporting System (VAERS) had posted 358,379 adverse events, including 5,993 deaths and 29,871 serious injuries.
- In the European Union's database of adverse drug reactions from COVID shots, called EudraVigilance, there were 1,509,266 reported injuries, including 15,472 deaths as of June 19, 2021. EudraVigilance only accepts reports from EU members, so it covers only 27 countries. Remarkably, about HALF of all reported injuries — 753,657 — are listed as “serious”
- The British Yellow Card system had, as of June 9, 2021, received 276,867 adverse event reports following COVID “vaccination,” including 1,332 deaths.

[I watched an interview with Eric Clapton](#), young people might not know the famous guitar player known as 'slow hand'. Now it is 'screwed hands'. He could not use his hands for 3 weeks after his 2<sup>nd</sup> shot and still has trouble with them, a known neurological side effect.

If you take these experimental vaccines you are SOL as far as compensation form drug companies as they are indemnified against lawsuits as **the vaccines are not FDA approved but for emergency use only**. I am not a lawyer but some vaccine victims are suing the doctors and pharmacies because they were not warned about any side effects. The health organizations now admit and warn that heart inflammation is a possible side effect of Astrazenica and the m RNA (Moderna/Pfizer vaccines).

It makes no sense that Covid-19 is such a panic and emergency. Why rush a vaccine so quickly for a disease that is not very fatal. Why so many government restrictions? Why all the lies and exaggeration on Covid-19. Why all the censorship and punishment to scientists and medical professionals if they ask questions or don't tote the government story?

**This is the most bizarre and an attack on our freedoms than has ever happened in history. It is obvious that there is much more to their agenda than public health and safety. I am going to review the most popular theories that will be the end game of Covid-19.**

## **1 – The most obvious is a power and money grab.**

Governments have enacted all kinds of rules and regulations that would never fly without a pandemic fear. Most worrisome is the censorship on freedom of speech. We now know Dr Fauci coerced with big tech to censor anything that was not pro government action and pro vaccine. The Trudeau government enacted bill C-10 to control the internet and as soon as they got that passed they introduced bill C-36 that [rebelnews describes as worst censorship law of any western democracy](#).

Money was not spent like drunken sailors, but more like drunken sailors on steroids and drugs too. Maybe it was zombie money? You all know about the spending and stimulus. Here is one example on the total incompetence of it all.

In general, governments, health systems, big pharma, big tech and a lot of big business exploited the pandemic at the expense of small business and the man on the street. A lot of government Covid relief money was just dealt out to their family and friends. And they trickle out a little stimulus to appease the peasants.

Premier Ford of Ontario was believed to be worth about \$2 million when he took office, [and now estimates put him at \\$50M](#), sure a nice score in a few years.

## **2 – Vaccine passports, a new digital ID control system.**

There are too many crazy things that have gone on to believe all this elaborate scheme was done just for money and power. Surely they could do that easier as in the past on lesser scales. Some believe the end game is to have everyone assigned vaccine passports so you can be tracked and controlled on what you can and cannot do. The passport would become like a security badge that lets you into certain parts of a building. Get your booster shot or you can't play golf or go to malls. Can't take a vacation unless your taxes are paid. Swipe your passport to buy gas for your car. Access to bank accounts denied for this reason or that.

I don't doubt governments would like something like this, but I don't think most people are ready to give in to this, maybe passive Canadians, but this idea has had strong opposition else where. **Israel and Britain, two countries farther along with vaccines have both abolished the vaccine passport idea. No this is not the end game.**

### 3 – mRNA vaccines a big experiment on gene therapy before introducing more.

There is no doubt this is a big experiment. I think this will be a once off trial with mRNA on Covid-19. In time, the vaccines will prove not near effective as promised and side effects will become a bigger problem. More people will witness in real life how bad these side effects can be. I don't think our bodies are built to take on synthetic production of anything, in this case the spike proteins. Among people I know that took the vaccine, about half don't show much in side effects short term while the other half show some pretty bad and weird side effects. These include blisters around the eye, severe headache, dizziness, vomiting, fatigue, pain all over and I know of one heart attack. More often after the 2<sup>nd</sup> dose. Many of these people were incapacitated for 1 to 3 days, could not function and some are regretting getting the vaccine. These type of side effects and numbers are not normal at all for any vaccine or drug. **The VAERS system has more side effects reported now than there has been in the past 30 years for all drugs and vaccines combined.**

Just this Monday a good friend of mine told me one of his friends almost died with heart problems after the 2<sup>nd</sup> dose. That person's heart was down to 10% in the hospital and is now back to 35% of what it was, but now in such weak condition, this poor soul cannot continue a normal life.

I listened to a recorded call a woman had reporting her severe side affect to Moderna. She can no longer walk. During that call, the Moderna representative reads her the following disclaimer:

*“The Moderna COVID-19 vaccine has not been approved or licensed by the Food and Drug Administration, but it has been authorized for emergency use by the FDA under an emergency use authorization to prevent coronavirus disease 2019, for use in individuals 18 years of age and older.*

*There is no FDA-approved vaccine to prevent COVID-19. The EUA for the Moderna COVID-19 vaccine is in effect for the duration of the COVID-19 EUA declaration, justifying emergency use of the product unless that declaration is terminated or the authorization is revoked sooner.”*

The rep also points out that all [clinical trial phases](#) are still ongoing, and that long-term protective efficacy against COVID-19 is unknown. When the patient asks whether everyone who gets the COVID shot — even if they did not specifically sign up to be a trial participant — is in fact part of the clinical trial, he replies, with a chuckle, “pretty much, yeah.”

### 4 – Experimental vaccines works as the propaganda story line suggests, Covid-19 subsides and everything goes back to normal.

We would all like to believe this, but in reality if you want a definition of a fairy tale, than this is it.

### 5 – Experimental vaccines do not work well and cause more harm than good. Could also be part of a plan of population reduction and infertility.

**This sounds like the conspiracy theory and many of you will think I lost my mind. Remember this is a theory and I only present the data to support it.**

**These are the facts we know so far:**

- These experimental vaccines do not stay in the shoulder muscle as previous ones do;
- A Japanese scientific study found that the most spike protein created by the vaccines accumulates in the ovaries. This is not normal and alarming;
- Vaccine adverse reporting of severe side effects and deaths is historically off the charts;

- My own experience with people I know shows about half reporting weird side effects that are simply not normal for any drug or vaccine;
- Severe censorship of any doctor or scientist that raises any concern about the experimental vaccines. Censorship is not how science works - why is freedom of speech being attacked;
- Unprecedented government spending on advertising and gimmicks to promote said vaccines;
- Huge panic on a virus that is not very deadly, you have to get two vaccine shots, it has only been 5 or 6 months and they are taking about a 3<sup>rd</sup>. This is unprecedented in history;
- Israel and the UK were the first two countries to start aggressive vaccine campaigns and have the most vaccinated. They have both reported a large decline in vaccine effectiveness;
- Variants don't make a big difference. Pretty much all of the UK Covid-19 this year was the Delta variant and cases plummeted as the flu season ended as is normal.

Now, I am going to provide **very strong factual and alarming evidence**, that of course the main stream media will never report. Although they won't report it, this information is in the public domain. Maybe that is how governments plan to protect their ass, they can say they published the alarming data.


[Professor Tim Spector, who runs Britain's largest Covid symptom tracking study](#), said new cases peaked at around 33,000 per day on July 6.

Symptomatic cases among unvaccinated Brits fell by 2.4%, from 20,973 on July 5 to 20,487 on July 6.

But the number of vaccinated adults —who make up 87.2% of the population — falling ill with the virus is still rising.

Another 12,905 vaccinated Brits were estimated to have caught Covid on July 6, meaning **nearly half of all cases are now among the jabbed.**

The data led Professor Spector, who is an epidemiologist at King's College London, to conclude that total new cases among both groups have plateaued at 33,000.



This next data is [from UK Public Health, so it is government data](#). The main stream can ignore and hide the data, but you cannot change the facts and truth. It is very sad that although it is public data in the public domain, government and no main stream ever mentions it. I highlight in red, what I am going to talk about here.

Because they break the data down in 3 sub sets for vaccinated, we have to add the 3 together. So there is 17,642 Covid-19 cases with vaccinated people and 35,521 among Unvaccinated. UK only started to ramp up with 2<sup>nd</sup> dose in February so is why a lower number with 14 days after dose 2.

**The first obvious observation is a lot of vaccinated people are still getting Covid-19, but what is worse is the death rate.**

**More vaccinated people died, 37 compared to 34 Unvaccinated.** However the death rate is much higher with the vaccinated people because there were far fewer cases. The death rate of vaccinated is .0957% (34/35,521) while the death rate of vaccinated is 0.209% (37/17,642). **The death rate among the vaccinated is more than twice as high.** This might be the same cause that was observed in animal studies in early day testing of mRNA. And why mRNA never got past animal studies until now as a human experiment.

**We are still only 5 to 6 months into these experimental vaccines, but this data and trend is very troubling.** However for these vaccines to be down graded in effectiveness so soon by the leading vaccinated countries is a very bad trend that is probably just starting. If the first 2 doses don't work, why would the 3<sup>rd</sup>. Have yo heard the phrase, '*fool me once, shame on you – fool me twice shame on me*'.
